### **SPECIAL REPORTS**

Shan Jorgenson-Adam, Principal CPE provided an update on the status of the Aboriginal Enhancement Agreement. After the signing of the Enhancement Agreement in March, 2010, there have been a number of meetings to develop an Implementation Plan. The Aboriginal Advisory Committee meets monthly to ensure that the Agreement is a living document. The district is currently refining strategies to support implementation. At the last meeting of the Aboriginal Advisory Committee, it was decided in the New Year to form an Ad Hoc Committee made up of Revelstoke Secondary School Aboriginal Students to provide further feedback.

A brochure has been prepared to raise awareness and receive input from the community.

Shan Jorgenson-Adam, Principal CPE commented that the reason for the success of the program was that the committee is very passionate and have made a commitment to have an implementation plan to achieve goals. It is key to build ownership and relationships.

Trustee Wilson, on behalf of the Board thanked Shan Jorgenson-Adam for her significant contribution in the district.

Superintendent Cooper highlighted the full day kindergarten implementation session attended by teachers, Tracy Spannier, Early Childhood Development Coordinator and Jenny Stokman, Manager of Care, Stepping Stones Childcare Centre, to review the implementation of full day kindergarten in September.

## Superintendent's Achievement Report

#### 10: R-101 Morrone/Hamilton

Superintendent Cooper presented, with great pride and pleasure, the Superintendent's Annual Report on Student Achievement, which will be submitted to the Ministry. Superintendent Cooper highlighted that this is the seventh successive year that over 90% of student left grade 3 with the reading skills they need for continued success. 98% of Grade 4 student met or exceeded expectations for writing in 2010. 95% of Grade 7 students met or exceeded the district benchmark for reading fluency and 95% met or exceeded expectations in writing for 2010. The Six-year Dogwood completion rates in our district were 98% for 2009/2010; the highest in the Province and the Six-Year Completion Rate for Aboriginal Students was 82% in 2009/2010, which is 30% high than the provincial average.
