Mountain View Elementary School

Principal Cooper presented the Mountain View Elementary School Annual Report and advised that enrolment for the 2011-2012 school year has increased slightly. Principal Cooper praised the Parent Advisory Council and stated that the Parent Advisory Council "makes Mountain View Elementary School a better place". He commended staff for their contributions to school activities and their use of programs offered by the Community such as the Drug Abuse Resistance Education (DARE) program. He also thanked the RCMP for their support of the DARE program. Principal Cooper concluded by saying that he was looking forward to the 2011/2012 school year, as it will be a celebration year. It will be the last year of operation for the school and the staff, students, and Parent Advisory Council are working together to come up with ways to celebrate the history of Mountain View Elementary School.

Trustee Wilson commented that Mountain View Elementary School staff are "doing a wonderful job". Trustee Nicholson commented that he enjoys walking through the school to "see the many interesting things that are going on in the school". Superintendent Cooper thanked the staff and said that she greatly appreciates the efforts of staff in the myriad of activities offered at Mountain View Elementary School.
