#### **SUPERINTENDENT COOPER**

Administration Report: Superintendent Cooper

Received as information.

Superintendent Cooper reviewed the Superintendent's Activities highlighting the meetings that have been held to date with community groups to receive their input with respect to the performing arts centre. She also noted the most recent Progress in International Reading Literacy Study (PIRLS), which indicates that the performance of grade 4 students in each of our schools is either at or above the international benchmark. Superintendent Cooper acknowledged the Parents as Literacy Supporters Program and Tracy Spannier, Early Childhood Development Coordinator. She also acknowledged the Canadian Avalanche Centre for the invaluable snow safety programs they are providing to students in our district and thanked Acting RTA President Jennifer Wolney for her assistance with elementary reporting.

Superintendent Cooper reviewed the request received from the Revelstoke Early Childhood Development Committee for endorsement of the Revelstoke Children's Charter.
