SUPERINTENDENT COOPER

Administration Report: Superintendent Cooper

Received as information.

Superintendent Cooper reviewed her Administration Report highlighting the Middle Years Development Instrument and the many programs the Revelstoke Community Social Development Committee is involved with in particular, the Revelstoke Youth Initiative, which has secured funding to support its initiatives. Superintendent Cooper also elaborated on her meeting with the two parents interested in pursuing early French Immersion in our district.
