SUPERINTENDENT COOPER

Administration Report: Superintendent Cooper

Received as information.

Superintendent Cooper reviewed her report highlighting a number of items, including: the "Mathletics" program which will be adopted district wide; Ewan Urguhart a Grade 12

Revelstoke Secondary School who has been very helpful modifying the fire plans; and the development of a transition plan for Mike Hooker as Superintendent Designate.

Chairperson Chell thanked Superintendent Cooper for her service and leadership over the years and reviewed the process used in choosing Mike Hooker as her successor.

Chairperson Chell noted that the performing arts centre would be completed next week and then orientation and training will begin and will include members of the theatre community.

Policy 3.9 School Completion (Evergreen) Certificates

Superintendent Cooper explained the background for the policy. The policy is made in accordance with the School Act and a Ministerial Order and the requirements for an Evergreen Certificate parallel the requirements of a Dogwood Certificate.

2012/2013 Annual Facility Grant Funding

Secretary-Treasurer Ross advised that the Annual Facility Grant for 2012/2013 is \$307,415, and that a spending plan will be developed for Trustees' review prior to the submission to the Ministry by the April 30th, 2012 deadline.

2012/2013 Estimated Operating Grants

Secretary-Treasurer Ross presented the 2012/2013 Estimated Operating Grant in the amount of \$9,951,099. This amount is based on an estimated enrolment of 1,017 students. Staff will continue to monitor enrolment to ensure that any reductions will be addressed in the budgeting process.

DISTRICT PRINCIPAL, OPERATIONS & TECHNOLOGY WOODHURST

Capital Projects Update

District Principal of Operations & Technology Woodhurst confirmed that work on the elementary school is proceeding rapidly and is on schedule. It is anticipated that the Early Learning Hub and Gymnastics areas will be completed slightly ahead of the classroom areas. He also noted that Graham is working on the list of deficiencies at Revelstoke Secondary School and that the theatre will be completed within a week. Superintendent Cooper advised that the Revelstoke Secondary School Servery is now completed and that Heidi and Mark Kinoshita of Heimark Industries Limited operating as Kino's Snacks have signed the Servery Contract and food service will begin on Monday, April 2nd, 2012.

Chairperson Chell noted that it was an excellent meeting with attendees discussing what they can do to make the transition successful.
