#### SUPERINTENDENT COOPER

#### Administration Report: Superintendent Cooper

# New Elementary School Name

Finance and Facilities Committee Minutes of April 5<sup>th</sup>, 2012

Trustee Chell reviewed the process for choosing the school name explaining that of the approximately 60 suggestions received, the names were put into 3 categories, Geographic, Names of Individuals and Other. Trustees discussed the criteria for the name and decided that the name should be geographic and unique to Revelstoke. Six names were short-listed and those names were cross-checked against other schools

and/or communities in British Columbia with the same or similar names. The name that was chosen was Begbie View as the name combines the names of the two schools being consolidated, the school will have an excellent view of Mt. Begbie and Mt. Begbie is unique to Revelstoke.
