Aboriginal Education Enhancement Agreement – Annual Report

District Principal, Support Services Smillie presented the Aboriginal Education Enhancement Agreement Annual Report for 2011-2012. She reviewed the many activities noting that a field trip to Vancouver for Revelstoke Secondary School students attending the National Aboriginal Achievement Foundation Education Series was a highlight for the students. District Principal Smillie also reviewed the mission statement and the four goals which were: to increase aboriginal students' knowledge and pride of their heritage and language; increase every students' awareness of the culture and heritage of Aboriginal peoples; increase the academic success of Aboriginal students with increased literacy, numeracy and technological competencies; and increase aboriginal students' successful completion of their secondary

education. She reported on the strategies used to support each of the goals and the performance indicators/evidence of the goals. District Principal Smillie expressed her thanks to the Committee members including Chairperson Margaret Verhaeghe, Trustees Morrone and Dubasov, Lynne Barisoff, Supervisor of Aboriginal Student Services and Lisa Moore, Aboriginal Student Assistant.

Trustees Morrone and Dubasov noted the hard work of the committee over the years and complimented District Principal Smillie on an excellent job. Superintendent Cooper expressed her thanks to District Principal Smillie for a fine job. Trustee Chell commented that it is clear from our district and others throughout the province that if you set targets and develop a work plan, you will see results.

SUPERINTENDENT COOPER

Administration Report: Superintendent Cooper

Received as information.

Superintendent Cooper presented her report highlighting the article she wrote titled "Revelstoke's Neighbourhood Learning Centre – So Much More Than a Building". The article was published is the Spring 2012 issue of "The Early Childhood Educator" publication. Superintendent Cooper noted that the joint Mount Begbie and Mountain View Elementary Schools have now elected the Parent Advisory Council for Begbie View Elementary School. She also noted the presentation made by herself, Linda Chell, Early Childhood Development Committee Chairperson and Tracy Spannier, Early Childhood Development Committee Coordinator to the Family Action Network in Trail, BC. Superintendent Cooper was happy to report that the annual Educational Assistant/Personal Care Attendant meeting was convened followed by a bidding session and that all regular employees have positions for the 2012/2013 school year.

Trustee Morrone requested clarification of the pilot project with the Special Education Branch. Superintendent Cooper explained that the goal of the pilot project is to use fewer resources on obtaining a diagnosis/category for special needs students and instead use those resources to provide support.

Trustee Dubasov congratulated Superintendent Cooper and Confidential Secretary Magarian on the official opening of the Revelstoke Performing Arts Centre.

Secretary-Treasurer Ross reviewed the Budget noting that it was a challenging budget to prepare due to the uncertainty with respect to the completion of the two capital projects, which contain the Neighbourhood Learning Centres. The maintenance and custodial needs of the new facilities are

not yet finalized. Staffing levels have been reduced due to enrolment and the school consolidation.

Trustee Chell commented that he appreciated the difficulty with preparing the budget and noted that it will take time to finalize costs for the new facilities. He also commended district staff for putting funds into classrooms in order to maintain the small class sizes in our district. He also thanked the district staff for their work given the huge workload they currently have.
