SUPERINTENDENT COOPER

Administration Report: Superintendent Cooper

Received as information.

Superintendent Cooper reviewed the 2012/2013 District Achievement Contract. Superintendent Cooper pointed out that since 1995 there has been a 43% decline in student enrolment, which poses a significant challenge in maintaining small class sizes while enhancing services and programs for students. Superintendent Cooper noted that Goal 1 "To Increase Students' Reading Achievement" and Goal 2 "To Increase the Number of Students Graduating and Completing School" have been sustained and the hope is that this year more work can be done on Goal 3, which is "To Support Students' Health and Well-Being".

Middle Years Development Instrument 2012 District Report

Superintendent Cooper reviewed the report with trustees. She advised that the information contained in the report will be shared with the community and that each school will be sharing the information with their staff. In summary, the data indicates that the students in Revelstoke are thriving but that work can always be done to support students' well-being.

Revelstoke Secondary School – Transitions to Post-Secondary Institutions

Superintendent Cooper reviewed the Ministry's data on secondary school transitions to post-secondary institutions noting that 72.3% of students who graduated from Revelstoke Secondary School in the 2005/2006 school year moved on to post-secondary education. The district will continue to update the chart as the data becomes available.
