SUPERINTENDENT HOOKER

Administration Report: Superintendent Hooker

Received as information.

Superintendent Hooker reviewed his administration report highlighting the Ono Cho visit noting the bonds the visitors from Ono Cho made with our students and the host families in such a

short time. He provided Trustees with an update on the French Immersion review. He noted that in the first 3 days of Kindergarten registration for the 2013/2014 school year a total of 47 students were registered for Kindergarten at the three elementary schools. He further noted the outstanding work being done at so many levels in the district and highlighted a classroom at the high school using technology in a very student centered and motivating way.
