#### **SPECIAL REPORTS**

Arrow Heights Elementary School Annual Report

Arrow Heights Elementary School Principal Todd Hicks presented the 2012-2013 Arrow Heights Elementary School Annual Report to the Board. Using a power point presentation, he noted that the cornerstone of the school is the Code of Conduct – Cooperation Achievement Respect Enthusiasm Safety (CARES). He reported on some of the new initiatives at the school such as "The Great Number

Rumble", "Family Numeracy Evening" and "Battle of the Books". Principal Hicks then highlighted some of the social development activities involving student participation such as designing a t-shirt for Anti-Bullying Pink Shirt day and AHE Connects, which involves partnering up with other students in the school on Friday afternoons for various activities. Students also raise funds for Trees for Tots, Stones into School, Rick Hansen Foundation and Good Samaritan Shoe boxes.

Principal Hicks presented data that he and the staff are using to monitor success at the school. He thanked teachers, support staff, parents, Parent Advisory Council and the many community partners for their hard work in creating a positive learning environment for students. He added a special thanks to the Revelstoke Credit Union and RCU Insurance for the speed boards set up along Nichol Road.

Trustees thanked Principal Hicks for a comprehensive report and commended the joint effort between the school and the community. Trustee Nicholson commented that the data presented by Principal Hicks was fascinating and he is impressed with the many good programs at the school.

Superintendent Hooker acknowledged the work being done at the school by teachers and support staff.

Trustee Chell on behalf of the board offered his congratulations to Principal Hicks, the students, staff and parents at Arrow Heights Elementary School for creating such a welcoming school.

## Aboriginal Education Enhancement Agreement Annual Report

Superintendent Hooker presented the Aboriginal Education Enhancement Agreement Annual Report for 2012-2013. He reviewed the mission statement and the four goals which are: to increase aboriginal students' knowledge and pride of their heritage and language; increase every students' awareness of the culture and heritage of Aboriginal peoples; increase the academic success of Aboriginal students with increased literacy, numeracy and technological competencies; and increase aboriginal students' successful completion of their secondary education. He reported on the outcomes of the strategies used to support each of the goals noting that most of the students have now identified their heritage. He also reported on the many activities at elementary and secondary schools and reviewed the performance indicators/evidence data. Superintendent Hooker expressed his thanks to Committee members especially Chairperson Margaret Verhaeghe. He also thanked Lynne Barisoff, Supervisor of Aboriginal Student Services, Lisa Moore, Aboriginal Student Assistant and Lissa

Cancilla-Sykes, Aboriginal Support Class Teacher, for their work with aboriginal students and for their contributions to the report.

Trustees noted the hard work of the committee and that pride and cultural awareness is vitally important to student achievement.
