Columbia Park Elementary School Annual Report

Columbia Park Elementary School Principal Ariel McDowell presented the 2012-2013 Columbia Park Elementary School Annual Report to the Board. Using a "Prezi" presentation, she reviewed the School's Mission Statement, which sets the tone and direction of the school. She also reviewed the

School's Code of Conduct which consists of the RAISE (Respect all Individuals, Self and Environment). Principal McDowell explained how "GOTCHAS" are used in focusing on the positive behaviours of students and then reviewed the School Growth Plans and the data used to formulate the goals. She highlighted the goal of "Connectedness" explaining the different ways school staff are ensuring that students feel connected to the school. In closing, Principal McDowell noted that parents and the Parent Advisory Council are an integral part of the school and she thanked the dedicated teachers and support staff for making Columbia Park Elementary School exceptional. She then presented a slide show for Trustees which highlighted students, staff and parents engaging in the many activities that take place throughout the school.
