SPECIAL REPORTS

Revelstoke Secondary School Annual Report

Revelstoke Secondary School Principal Greg Kenyon presented the Revelstoke Secondary School 2012-2013 Annual Report to the Board. He began by thanking the board for giving him the opportunity to be the Principal of Revelstoke Secondary School, Mike Hooker, Superintendent of Schools and Anne Cooper, Associate Superintendent for mentoring him and Vice-Principal Andy Pfeiffer for his support and assistance. Principal Kenyon then reviewed the 2012-2013 School Growth Plan goals on

School Completion and Literacy. He began with School Completion and Academic Achievement noting the hard work that is being done by teachers and support staff to ensure student success. Principal Kenyon presented data that indicated that the achievement grades for all students at the B or better rate are maintained at a very high level, that fail rate are consistently below 3% and that 92% of students feel connected to two or more adults at the school. He noted that connectedness is an important factor in student success. He added that the school has a strong school culture and that each and every student is valued.

Vice Principal Pfeiffer reviewed the 2012-2013 Literacy Goal. He briefly reviewed the processes for collecting data noting that although the school will not have complete data until the end of June, the data collected to date indicates that the literacy goals are being achieved.

Principal Kenyon reviewed some of the many activities being held at the school, most of which are student led including the very successful "Love is Louder" event, which was held at Revelstoke Secondary School on Friday, May 24th, 2013. In conclusion he presented a "Love is Louder" slide show created by Revelstoke Secondary School students.

Trustees thanked Principal Kenyon and Vice Principal Pfeiffer and asked that they offer congratulations and thanks to the staff at Revelstoke Secondary School. Superintendent Hooker offered his congratulations on the report adding that Revelstoke Secondary School is a "great school with great staff".
