DELEGATIONS

Jennifer Wolney, President of the Revelstoke Teachers' Association, spoke to the letter addressed to the Board from the Revelstoke Teachers' Association dated June 11th, 2013. Ms. Wolney expressed the concerns of the Revelstoke Teachers' Association with the provincial government's desire to negotiate a 10 year Collective Agreement as well as concerns over recent government action with respect to the bargaining process. On behalf of the Revelstoke Teachers' Association, Ms. Wolney requested that the board pass a motion to send a letter to the Minister of Education asking him to reconsider the proposed 10 year Collective Agreement. Trustees thanked RTA President Wolney for her presentation.

ADMINISTRATION REPORTS

SUPERINTENDENT HOOKER

Administration Report: Superintendent Hooker

Received as information.

Superintendent Hooker provided his Administration Report highlighting the Love is Louder event held at Revelstoke Secondary School noting that it was a very powerful event and ties in with the district's commitment to providing a safe, caring, learning environment for students. The Grade 6 and 7 elementary students in our district have now viewed a slide show of the event which was prepared by Revelstoke Secondary School students. Superintendent Hooker acknowledged the retiring district staff thanking them for their years of service to students. He noted that the district's retirement tea honouring the retirees was held on Monday, June 24th. He thanked the media for introducing Dr. Yanping Wang, the new principal of Begbie View Elementary School, to the community adding that she will be in Revelstoke next week and a lunch with the Begbie View Elementary School parent group is planned. Superintendent Hooker advised that two days of CUPE bargaining took place earlier this month and that Harry Nott, CUPE National Representative, attended the bargaining sessions and was very impressed with the relationship that exists between CUPE and the district.

2013/2014 Achievement Contract

Superintendent Hooker presented the 2013/2014 Achievement Contract. He noted that the Contract is a working document and is used throughout the year. He reviewed the 3 goals in the contract which are: "To Increase Student's Reading Achievement", "To Increase the Number of Students Graduating and Completing School", and "To Support Students' Health and Well-Being". He advised that areas that targets were not met will be of focus early in the 2013/2014 school year. He also advised that in the 2013/2014 school year there will be an emphasis on enhancing the social and emotional well-being of students including a new objective to increase the number of adults that middle and secondary students feel connected with at school.
