Administration Report: Superintendent Hooker

Superintendent Hooker reviewed his administration report highlighting the overnight trips of Begbie View Elementary School's Grade 7 and Grade 6/7 students to Mount MacPherson to foster team spirit and build leadership skills and the visit to our school district by Rick Davis, Superintendent of Achievement with the Ministry of Education.
