SUPERINTENDENT HOOKER

Administration Report: Superintendent Hooker

Received as information.

Superintendent Hooker reviewed his Administration Report highlighting the server and software updates being implemented by Michael Haworth, District Vice-Principal Technology, RSS

student Mackenzie Mallett's selection as MC for an event with the Dalia Lama at John Oliver Secondary School on October 21st, 2014, the near completion of the summer work plan and the tours of Begbie View Elementary School and Revelstoke Secondary School conducted by himself and Linda Chell, Early Childhood Development Committee Chairperson, as part of "Homecoming Weekend". He also noted his attendance at the British Columbia School Trustees Association Summer Leadership Academy and the presentation made at that session by Ariel McDowell, Principal of Columbia Park Elementary School, Kimberley Schonert-Reichl, Interim Director of the Human Early Learning Partnership, and himself, and a meeting with Tessa Graham and Jan White of the Provincial Office for the Early Years with respect to Revelstoke's selection as one of the 12 new BC Early Years Centres. He was also pleased to add that local CUPE bargaining was completed on August 26th, 2014 after a day and a half of bargaining.

Disposition of Surplus Schools Update

Superintendent Hooker reviewed the update noting the Big Eddy Elementary School site continues to be on hold and there have been a few changes to the Mountain View Elementary School work plan. The applications for Heritage Designation and Heritage Revitalization have been separated which allows the district to pursue Heritage Designation in order to protect the 1914 building regardless of ownership. Only the Mountain View Elementary School building will be dealt with at this time, the central school foundation currently underneath the field will remain in place until future land use is determined. He noted that Earl Woodhurst will be providing on-site supervision for the demolition project.

SECRETARY TREASURER TISDALE

Capital Project Bylaw

Secretary Treasurer Tisdale advised trustees that the Ministry of Education announced capital project funding for districts in the spring of 2014. In order for the district to access a portion of the funds for capital projects such as the kitchen at Columbia Park Elementary School, and the technology upgrades at Arrow Heights Elementary School and Columbia Park Elementary School, the Board must pass a Capital Project Bylaw.
