SUPERINTENDENT HOOKER

Administration Report: Superintendent Hooker

Received as information.

Superintendent Hooker provided his Administration Report highlighting the substantial amount of work being done by Todd Hicks, Principal AHE, and Michael Haworth, District Vice-Principal

Technology, in preparation for the switch from the BCeSIS student records software to MyEducation BC software. He noted the Ono Cho visit and the value for students and the community. He brought trustees attention to the Youth Initiatives Committee meeting he attending and expressed thanks to the Committee for their partnership in many programs which benefit our students.

Columbia Park Elementary School 2014/2015 School Growth Plans

Literacy

Superintendent Hooker noted that there has been significant adjustment to the plan which aligns with the district's literacy goal. He added that in the Success/Results section it not only lists percentages but also the number of students (ie "7 of 21.....33%"), which is very helpful when interpreting the data.

Numeracy

Superintendent Hooker noted that the plan aligns with the district's focus on revisions to the provincial numeracy curriculum for grades K-9 and that the objective of improving student confidence in Math is critical to the success in the objectives of improving numeracy skills and applied math skills.

School Connectedness

Superintendent Hooker reviewed the graphs based on data collected from the Middle Years Development Instrument (MDI) for Grades 4 and 7 and the Satisfaction Surveys for Grades 3 to 7 and brought trustees attention to the tracking of cohort groups. The data collected is used as a "conversation starter" with students, staff, parents and the school planning council in determining strategies and structures for this important area.

Disposition of Surplus Schools Update

Superintendent Hooker reviewed the Disposition of Surplus Schools Update highlighting the pending heritage designation on the Mountain View 1914 building. He added that once the City bylaw is passed and the covenant registered on the building, it will be a registered heritage site.

Energy Update

Superintendent Hooker informed trustees that the recent fire at the Downie Timber mill damaged the Revelstoke Community Energy Corporation's heating plant, which provides heat to Begbie View Elementary and Revelstoke Secondary Schools. It is unknown when the heating plant will be operational. He noted that the district installed back up propane boilers when the schools were being built and those are now being used to heat the schools.

SECRETARY TREASURER TISDALE

2014/2015 Amended Annual Budget

Trustee Rorstad explained that due to the unavailability of trustees, the Finance and Facilities meeting to review the budget could not be held until February 24th, 2015 and therefore, the budget and corresponding memo could not be included in the agenda package prepared on

February 19th, 2015. Trustees agreed to give all three readings of the bylaw at this meeting. Secretary Treasurer Tisdale then reviewed the key items that were adjusted from the 2014/2015 budget presented in the Spring 2014, including the loss of revenues and saving of expenses resulting from the September job action, the milder than normal weather conditions, increases in utility charges and increases in benefit costs.
