DELEGATIONS

Garry Pendergast and Janet Lemieux both of GRP Educational Services presented the results of the Revelstoke Workforce Survey noting that data is still being compiled. Garry Pendergast, using a power point presentation, reviewed the survey results noting that 150 businesses covering 3,260 jobs were surveyed. One of the questions asked of businesses was whether they anticipated increasing the number of their employees, maintaining the status quo, or decreasing their number of employees. Of the businesses surveyed, 45% anticipate expanding the number of employees, 49% maintaining the status quo and 6% anticipate reducing their workforce. Mr. Pendergast reviewed some of items that employers requested such as expanded trades training/apprenticeships and employee training in customer service, life skills and retail behaviour. He advised trustees that once the report is complete, it will be listed on the Revelstoke Chamber of Commerce's facebook page and the City of Revelstoke's website. Trustees thanked Mr. Pendergast and Ms. Lemeiux for the informative presentation.

2015/2016 District Calendar

Superintendent Hooker reviewed the process that was followed in establishing the calendar for 2015/16. He explained that the Ministry of Education sets minimum hours of instruction rather than days of instruction and noted that the district continues to maintain and protect instructional time for students. Superintendent Hooker explained that the draft calendar was circulated to the District Parent Advisory Council, each school's Parent Advisory Council, the Revelstoke Teachers' Association and CUPE for feedback several months ago and he encouraged anyone with concerns to email him. There was considerable feedback, which is represented in this proposed calendar.

This calendar makes provision for a two-week spring break without days of instruction dropping below the historical cycle of total annual days of instruction. This is due to the addition of two summer non-instructional days, and due to Good Friday and Easter Monday coming in the middle of the two week vacation period. The 2016/17 draft calendar will revert to the traditional one week vacation period and will go through the full consultation process before being brought to the Board in March of 2016.
