## SPECIAL REPORTS

Columbia Park Elementary School Principal McDowell presented the Columbia Park Elementary School 2014/15 Annual Report to the Board. Mrs. McDowell reviewed her written report beginning by highlighting the five dimensions of children's health and well being identified by the UBC Human Early Learning Project. The five dimensions are social and emotional development, physical health and well-being, connectedness, use of after school time and school experiences. Principal McDowell reviewed the many ways that Columbia Park Elementary School nurtures each of the five dimensions. She then reviewed the school's Code of Conduct noting that it was revised this year by staff, students and parents. Principal McDowell reviewed the Aboriginal Education program at the school noting that there are 31 students at Columbia Park Elementary School with Aboriginal heritage and that elementary students throughout the district have been working on a mural project which will be

unveiled at Revelstoke Secondary School on Thursday, June 18<sup>th</sup>, 2015. She noted the high level of parent involvement, the importance of early academic intervention and the chart being used as an assessment tool. Principal McDowell concluded her report with a slide show, which included videos of students.

Trustees thanked Principal McDowell for her informative report noting the Aboriginal program which includes all students not only those with Aboriginal ancestry, the detailed chart used as an assessment tool and the revised Code of Conduct. Trustees asked Principal McDowell to pass along their thanks to the staff for their work and their dedication to students.

## Administration Report: Superintendent Hooker

Received as information.

Superintendent Hooker provided his Administration Report highlighting the presentation by Bob MadDonald, host of CBC Radio's "Quirks & Quarks" at Revelstoke Secondary School, his meetings with Miriam Manley, Theatre Manager, in preparation for a presentation to Columbia Basin Trust on the partnership between the school district and the Revelstoke Arts Council with respect to the Revelstoke Performing Arts Centre. He noted that Educational Assistant staffing for 2015/16 is now complete with an enhanced level of Educational Assistant time.

Superintendent Hooker brought trustees attention to the Teacher Mentoring Program's yearend celebration for the 19 district staff who participated in the program and confirmed that the application process has begun for the 2015/16 school year. He commented on the success of ScreenSmart week due to the work of Stephanie Melnyk, Revelstoke Secondary School's drama students' excellent production of Virgil's Wedding, school band concerts and the Revelstoke Secondary School year-end awards celebrations.

Policy 2.1 Procedural Bylaw – Addition of Acknowledgement of Traditional Aboriginal Territories

Superintendent Hooker reviewed the process with respect to adding an acknowledgement of traditional Aboriginal territories to school board meetings.

"THAT the Board of Education approve the following wording to be used at the commencement of regular board meetings and the addition of an acknowledgement of traditional Aboriginal territories to Policy 2.1 Procedural Bylaw:

We would like to honour the four nations on whose traditional land we live and learn: the Sinixt, the Ktunaxa, the Secwepmec, and the Syilx. We respectfully acknowledge indigenous people, recognizing that our students come to us with Aboriginal ancestry from a variety of ancient homelands."

#### Policy 3.7 Human Rights and Discrimination

Superintendent Hooker reviewed the revised policy to which the words "gender identity" have been added in keeping with the district's new Sexual Orientation and Gender Identity policy.

#### Policy 5.6 Sexual Orientation and Gender Identity

Superintendent Hooker explained the process that took place in developing the new policy. He noted value of the input received from the Revelstoke Safe Spaces Committee, the Revelstoke Social Development Committee and the public. Jennifer Wolney, RTA President, was thanked for brining the original draft policies to the attention of the Policy Review Committee.
