Administration Report: Superintendent Hooker

Received as information.

Superintendent Hooker presented his administration report highlighting, the WE Day event held in Vancouver which was attended by 32 district students, the series of Last Spike Volleyball Tournaments organized by Revelstoke Secondary School teacher Barry Rourke, and the six staff members nominated as "Champions of Literacy". He noted a memo to all staff regarding the new policy on Gender Identity and Sexual Orientation, the "Junior Dragon's Den" presentation made possible by Kevin Dorrius, and the district's upcoming session on the implementation of the redesigned curriculum to be held November 23rd, 2015 with teacher representation from each school.

2015/16 Achievement Contract

Superintendent Hooker presented the 2015/16 Achievement Contract noting it is not required to be submitted to the Ministry at this time as the Ministry is currently reviewing and making changes to the accountability framework. He noted that the district's mission and vision statements are incorporated into the three goal areas of supporting student's health and wellbeing, increasing students' reading achievement, and increasing the number of students graduating and completing school. He explained that the "Actions" section at the end of each of the goal areas is a to do list and is a living document that is continuously being reviewed and updated. He brought trustees attention to the Aboriginal Education working being done in the district, including the finalizing of the district's second Enhancement Agreement, which will be signed this year.

2015/2016 Report on the Organization of Classes

Superintendent Hooker reviewed the 2015/16 Report on the Organization of Classes noting that the "snapshot" date was October 15th, 2015 and the report will be submitted to the Ministry by October 30th, 2015. The report outlines enrolment and class size averages and represents our commitment to ensuring that class sizes are protected and that a full range of courses are offered at our high school.

Some of the topics discussed were implementation of the redesigned curriculum, the Framework for Enhanced Student Learning, student assessments, and financial accountability.

Trustees Chell and MacFarlane attended the meeting. Trustee MacFarlane attended as the district's designate and Trustee Chell attended as a director of the BCSTA. The meeting included sessions on conflict of interest, financial audits, conflict resolution, and general communication strategies.
