SUPERINTENDENT HOOKER

Administration Report: Superintendent Hooker

Superintendent Hooker presented his Administration Report highlighting the melding of the language in the 2011-2013 and 2013-2019 Teachers' Collective Agreements. He noted the upcoming Non-Instructional Day which has been designated as a day for staff to work together on topics related to the redesigned curriculum, assessment, and reporting. He advised that Mark Jummun will be starting in his new position as the district's Secretary Treasurer at the beginning of January and that Secretary Treasurer Tisdale will stay on to ensure a smooth transition. Superintendent Hooker added that the November 22nd, 2016 Student Reporting Information Session hosted by the Education Committee was well attended by approximately 30 people.

Trustee MacFarlane provided a brief summary of the recent Supreme Court of Canada ruling made on November 10th, 2016 in favour of the BC Teachers' Federation. He noted that the current Collective Agreement was negotiated to include language in anticipation of the court ruling. Further updates will be provided as the process moves forward.
