SUPERINTENDENT HOOKER

Administration Report: Superintendent Hooker

Received as information.

Superintendent Hooker provided his Administration Report highlighting his weekly meetings with Bob Rogers, RTA President, and the Revelstoke Secondary School Christmas band concert which included a welcome back for returning band director, Tessa Davis. He also noted his meeting with the organizers of the French Language Experience Program and the district's support of the expansion of the program, currently at Begbie View Elementary School, to Arrow Heights and Columbia Park Elementary Schools. He also brought trustees attention to the work being done by Craig Weiler, Jeff Colvin and Greg Kenyon at Revelstoke Secondary School (RSS) as they prepare a proposal to the Ministry of Education for funding to enhance the trades programs at RSS. Superintendent Hooker expressed his thanks to Trustees MacFarlane and Rorstad for their involvement on the Principal/Vice-Principal Management Committee and the recent transition of Principal and Vice-Principals salaries to the Regional Salary Model approved by the Public Sector Employer's Council.

2016/2017 Achievement Plan

Superintendent Hooker began his presentation of the 2016/2017 Achievement Plan by explaining the purpose of the document adding that the Achievement Plan, in addition to being put on the district's website, is shared with the broader community to share our successes and challenges. He proceeded to review the three goals: *To Support Student's Health and Well-Being, To Increase Student's Reading Achievement* and *To Increase the Number of Students Graduating and Completing School.* Superintendent Hooker explained the methods used to collect data, noting that the performance indicators from the Middle Years Development Instrument (MDI) are used to ask "What are the things we should be doing?". He praised the Aboriginal Education Advisory Committee for their ongoing work.

Trustee Nicholson noted the recent press releases disclosing the results of the 2015 Program for International Student Assessment in which Canada placed 4th overall.

Superintendent Hooker reviewed the changes to the policy noting that the changes were made to reflect the district's priority use of district facilities for early learning programs.
