### SPECIAL REPORTS

## Columbia Park Elementary School 2016/2017 Annual Report to the Board

Andy Pfeiffer, Principal of Columbia Park Elementary School presented his report noting that he has found his first year as Principal of Columbia Park Elementary School, challenging, taxing and very rewarding. He began his presentation with the school's focus of the year, which has been Growth Mindset. The philosophy behind a Growth Mindset is that anyone can learn anything and that struggling in your learning is better than immediately picking up on something and failure should be embraced as FAIL means "First Attempt in Learning". Mr. Pfeiffer added that he uses twitter/social media to share ideas such as Growth Mindset, to communicate with parents, to promote activities at the school with the community and beyond. He then provided trustees with an example of one of his tweets about Growth Mindset.

The next topic of the presentation was the school's goal "To enhance levels of health and wellbeing for all students". He advised that the Middle Years Development Instrument is used as an assessment tool which helps the staff determine what strategies to use to improve student health and well-being. Mr. Pfeiffer noted that a number of staff, on their own time and initiative, have been able to access various grants and donations of equipment etc. A couple of the projects the staff was able to raise funds for are an outdoor learning space which will hopefully be ready for use in the Fall, and a donation of laptops from SetBC. One of the projects the Grade 6 students used the laptops from SetBC for was a project related to body image.

Mr. Pfeiffer discussed the redesigned curriculum, and how it has been implemented in the past year with such things as Exploration Fridays. Exploration Fridays take place on Friday afternoons for students in Grades 5, 6 and 7. The students are placed into three mixed grade level groups. Over a three month period groups rotate through three categories, Art, Drama and Technology. The categories are based on teacher strengths and the students are able to choose their activities which cross the curriculum. He added that students are now excited to come to school on Fridays.

He concluded by highlighting that everything is built on connectedness and relationships can happen with simple things like a smile. He thanked his "amazing" staff and concluded the presentation with a slide show.

Trustees and Superintendent Hooker thanked Principal Pfeiffer for his presentation noting the school's focus on the positive is creating a fun, active and engaging environment for students.

# 2017/2018 Provincial Funding Announcement
