# SUPERINTENDENT HOOKER

Administration Report: Superintendent Hooker

Received as information.

Superintendent Hooker reviewed his activities highlighting the student led Remembrance Day ceremonies held at each of the schools and the respect and leardership students demonstrate during the ceremonies, and the outstanding presentations by Dr. Vanessa Lapointe which,

based on brain research, focus on the importance of relationships. He also brought trustees attention to the BC School Superintendents Association conference he attended. One of the speakers was Dr. Blye Frank, Dean of the Faculty of Education at UBC. The topic of Dr. Franks's presentation was the redesigned curriculum and the affect the changes have had on the long-held practices of post-secondary institutions. He confirmed that post-secondary institutions are becoming partners with the Ministry in the changes to the curriculum. As for the disposition of the Big Eddy site, Superintendent Hooker confirmed that the district is still awaiting Preliminary Layout Approval (PLA) from the City of Revelstoke. Unfortunately, until the City has issued the PLA, the district cannot begin to market the lots.

### Ministry of Education's Large Scale Assessment and Learning Resources Policies

Superintendent Hooker reviewed the attached letter from Suzanne Hoffman, Superintendent of Learning Transformation with the Ministry of Education regarding the Ministry's recently updated Large Scale Assessment Policy and Learning Resources Policy. The policies were attached to provide trustees with background information. Superintendent Hooker explained that the intention of the policies is clearly set out with the wide scale assessment clearly defined.

#### School Codes of Conduct – Annual Review for 2017/18

Superintendent Hooker confirmed that each school completed the review its Code of Conduct and reviewed the summaries provided by principals, of the processes they used to engage students, staff and parents.
