SPECIAL REPORTS

Columbia Park Elementary School 2017/2018 Annual Report to the Board

Andy Pfeiffer, Columbia Park Elementary School Principal, began his presentation by thanking the Board and stating that the main school goal continues to be student health and well-being. The school year began with a school wide project entitled "The Most Magnificent Thing". The book of the same title was read to the entire school during assembly, and each student was given a box to create something with (i.e. racecar, camera, burrito). This project aligned with the redesigned curriculum, as it involved the three components of critical thinking, analyze (hmm), question (huh?) and develop (Ah). When the projects were complete, they were all displayed and students walked through each classroom to view the projects. This was a great opportunity

for students to connect with each other and started the year on a high note. The school continues to focus on the growth mindset and reminds students that it is ok to fail. Students are encouraged to embrace the struggle, as it is their First Attempt In Learning (FAIL). With respect to the redesigned curriculum, the school continues with Exploration Fridays which have now been expanded to grades 4, 5, 6 and 7 and this year has included activities such as a "CSI" case and stop action animation. Principal Pfeiffer reviewed a few of the many activities which have taken place at the school, noting a secret song and dance all the students learned and surprised him with at an assembly. He highlighted the breakfast program which began last year with parent volunteers three days per week and as a result of the "Breakfast for Learners" grant and the generosity of parents and local businesses, is now five days a week and provides students with a "soft" start to the school day. He also noted the new outdoor classroom, which the school is anxious to begin using, thanks to the efforts of Teacher Molly Butler and Aaron Potter of Vic Van Isle and many, many volunteers. Special thanks to Mr. Jummun for the many hours of volunteering he did on the project. The power of celebration has become a big part of the school, as students and staff celebrate what is going on at school and showcase those activities at assemblies. He concluded his presentation by thanking the parents, staff and students for working together, building connectedness and relationships, and making Columbia Park Elementary School a great place to work.

Trustees and Superintendent Hooker thanked Principal Pfeiffer for his report noting that the strength of the staff is their focus on collaboration, and the connectedness and relationships that are built between staff, parents and students, which creates such a positive learning environment.
