ELECTION

Election of Board Chair

Secretary Treasurer Tisdale described the process outlined in Procedural Bylaw 2.1 for determining the Board Chair. He called for nominations from the floor for the position of Board Chair.

SUPERINTENDENT HOOKER

Election of BC School Trustees Association (BCSTA) Provincial Council Representative

Secretary Treasurer Tisdale explained that although previously, the district has appointed the BCSTA Provincial Representative and Alternate, the BCSTA requires that the Provincial Representative and Alternate be elected. Superintendent Hooker called for nominations from the floor for the position of BCSTA Provincial Council Representative.

Trustee Chell thanked trustees advising that if another trustee would like to step forward, he will step aside. He added that the Provincial Council meetings are open to all trustees.

Administration Report: Superintendent Hooker

Received as information.

Superintendent Hooker provided his Administration Report highlighting the increase of 4 educational assistants position to support students that are new to the community and require extra support. He also highlighted the work of Secretary Treasurer Tisdale, Principal Hicks and Manager of Operations Manson who are reviewing "break out spaces" at Begbie View Elementary School. He noted the high participation rates (85% - 95% district average) in the Foundation Skills Assessments (FSA) for grade 4 and 7 students. He thanked principals and teachers for their assistance with the FSA. He also thanked Principal Tedesco and District Principal of Support Services McDowell for their work in bringing speakers Adrienne Gear and Carole Fullerton to the November 9th, 2018 Curriculum Implementation Day. He acknowledged the work of Secretary Treasurer Tisdale on his negotiations with the contractors for the playground and renovation projects at Columbia Park Elementary School. It is anticipated that those projects will begin shortly.

District Plan for Student Success 2018/2019

Superintendent Hooker presented the 2018/2019 District Plan for Student Success noting that trustees will review the plan further during Trustee Orientation. He began by highlighting the District's Mission Statement which the Board will be reviewing and the inquiry questions students and staff ask themselves to create a healthy learning environment. He then reviewed the three goals areas, *To Support Student's Health and Well-Being, To Increase Students' Reading Achievement, To Increase the Number of Students Graduation and Completing School.* He noted that the data collected is used, as staff work on their school plans, in determining the goals and the best ways to support students in those goal areas. He added that indigenous ways of learning are becoming embedded into the curriculum.

Board Authority Authorized Courses at Revelstoke Secondary School – Indigenous Connections 10, 11 and 12

Superintendent Hooker provided background information on the difference between Ministry mandated courses and Board Authority Authorized courses. He noted that the Indigenous Connections course is a new course and was developed by District Principal Support Services

McDowell, Teacher/Counsellor Lissa Cancilla-Sykes and Teacher Erin England. Erin England will be teaching the courses in second semester.

Early Childhood Development Committee Meeting of September 17th, 2018 For information.

Early Childhood Development Committee Meeting of October 15th, 2018

Trustee Chell highlighted the successful Toy and Clothing Exchange which serves hundreds of people. He then explained that Revelstoke early learning community has benefitted from funding from the provincial government and Columbia Basin Trust which has enabled the Early Childhood Development Committee (which is made up of representatives from a wide range of areas Childcare, Social Services, Education, Speech and Language and the School District) to provide supports and services free of charge to young children and families in the community. Unfortunately, the government has withdrawn substantial funding which will have implications for the school district. He noted that due to the work of the early learning community, Revelstoke has the lowest vulnerability rates of kindergarten students in the Province according to the Early Development Instrument. A working group has been established which will look at creative ways to maintain needed services and programs. He noted that it is very important that children continue to be identified at an early age and be provided with support in their early years.

British Columbia Public School Employers' Association Fall Symposium Meeting on November 5th – 6th, 2018

Trustee MacFarlane provided an overview of the Symposium which was entitled Insight and Opportunities. The main topic of the symposium was teacher bargaining with discussion on local bargaining, arbitration avoidance, duty to accommodate and return to work. Cannabis in the workplace was also discussed. Trustee Chell added that the symposium was very worthwhile and that Keith Baldrey, Political Journalist for Global TV, was a guest speaker and provided his perspective on the upcoming teacher bargaining and the political climate in BC.
