# **SPECIAL REPORTS**

Food Literacy Programming and Potential Future Partnerships "Brain Food" presented by Melissa Hemphill, Community Connections Food Security Coordinator

Melissa Hemphill began her presentation by explaining the terms "Community Food Security". "Household Food Insecurity" and "Food Literacy". She then gave an overview of the current programs such as the Local Food Initiative, School Breakfast Program, "Farm to Table" for students in grades 4 and 10, "Little Sprouts" preschool program, "Growing Friends" an intergenerational food knowledge sharing program, Food Band and the Food Recovery program. As the Food Security Coordinator, she is responsible for implementing the community's Food Security Strategy which is determined by the Food Security Advisory Committee. Ariel McDowell, District Principal Support Services, is a member of the Committee.

Melissa explained that food literacy and increasing food literacy in schools is an important part of the Food Security Strategy, as food literacy impacts our students' nutrition and wellness, their involvement in climate action, their mental health, it provides a sense of belonging, and develops

practical lifelong skills. She provided trustees with a handout of the Food Security Strategy Recommendations and reviewed each one focusing on Goal 5 "Education – Increase knowledge of food security, local food systems and actions that can strengthen food security by public officials, community agencies, business owners and residents of Revelstoke". Melissa provided some suggestions such as the development of a specific school district policy, school gardens and the district's endorsement of a position paper. Melissa concluded her presentation noting that she is available to provide support to the district and that there are many other groups and organizations in the community that are also willing to provide support. "Clarify, Commit, Collaborate".
