SUPERINTENDENT HOOKER

Administration Report: Superintendent Hooker

Received as information.

Superintendent Hooker presented his Administration Reporting highlighting his meetings with RTA President Bob Rogers particularly since COVID-19, as the almost daily contact helps to ensure staff are being supported in their efforts for students. He also noted there were very few elementary teaching positions posted for the 2020/2021 school year and there will be only a few

blocks posted for Revelstoke Secondary School. Staffing has remained constant for the 2020/2021 school year. He added that he, Bob Rogers, RTA President, and Chair MacFarlane presented a gift to Sue Leach, teacher at Arrow Heights Elementary School to wish her well in her retirement. Greg Kenyon, Principal RSS, Jodi Wallach, Vice Principal RSS, RSS Team Leaders and staff have been drafting alternate plans for scheduling in the Fall, should students not return to full in-class instruction. Trustees noted Kathy Hoshizaki being appointed as the "Coach of the Year".

2020/2021 Annual Budget

Secretary Treasurer Tisdale noted that the 2020/2021 Annual Budget was reviewed in detail with trustees at the June 23rd, 2020 Finance and Facilities meeting. At Trustees' request, Secretary Treasurer Tisdale prepared an additional memo. Trustees emphasized the district's focus on ensuring the health and wellness of our students. Due to COVID-19, the Board is implementing a budget which will allow the district some flexibility to allocate funds to mitigate the impact of COVID-19 on the health and wellness of students.

Trustees thanked the staff and the members of the Budget Committee for their work on finalizing a budget when there is so much uncertainty surrounding the 2020/2021 school year.
