He then read from the book jacket of the book "Mamaskatch" written by Darrel J. McLeod. The book is a memoir of the author's childhood. His mother Bertha, was a residential school survivor.

#### SUPERINTENDENT HOOKER

#### Administration Report: Superintendent Hooker

Received as information.

Superintendent Hooker presented his Administration Reporting highlighting his upcoming performance review, the ongoing discussions with Interior Health regarding COVID-19 safety guidelines, his discussions with Bob Rogers, RTA President regarding class sizes and supports for students not yet fully in the classroom adding that the percentage of students that have returned to the classrooms is approximately 99%. He also highlighted his meeting with Clara Maltby, President CUPE 5150 regarding the September start up, staffing levels and safety protocols as well as the district's hosting of student teachers and educational assistants for practicums. He noted that the participation rates of parents completing the Childhood Experiences Questionnaire has dropped sharply as face to face meetings are no longer possible. He brought trustees attention to the recent City of Revelstoke's Social Development Committee meeting which was the last meeting for Jill Zacharias who has been the Social Development Coordinator for many years. He noted the significant impact Jill has had on the community and schools. Trustees noted the importance of the Social Development Coordinator position.

## Indigenous Education Equity Scan

Superintendent Hooker explained that the purpose of the Equity Scan is for the district to have a critical look at policy and governance to ensure that there is equity in the district in the areas of social justice, relationships, human rights, and the first people's principles of learning. He invited trustees to attend the October 15<sup>th</sup>, 2020 meeting of the Indigenous Education Advisory Committee with Joe Heslip, the Field Liaison with the Ministry of Education's Indigenous Education Branch. Trustee Zimmer and Chair MacFarlane will attend.

## <u>COVID-19 Update – Why school is important to students</u>

Superintendent Hooker presented the BC Centre for Disease Control and BC Children's Hospital document entitled "Impact of School Closures on Learning, Child and Family Well-Being During the COVID-19 Pandemic. Trustee discussed the immense pressure the Provincial Health Office and the Ministry of Health are under as they guide the province through the COVID-19 pandemic.
