

Regular Board Meeting November 18th, 2020 Minutes

CALL TO ORDER

Trustee MacFarlane called the meeting to order at 5:00 p.m.

ACKNOWLEDGEMENT

Trustee Pendergast provided information on the Syilx people. The Syilx people of the Okanagan Nation made up of 7 member communities in the Southern Interior of British Columbia. They are a trans-boundary tribe separated at the 49th parallel. The name "Syilx" takes its meaning from the word "Yil" which refers to taking many strands and rolling and twisting them together to form one. The word Syilx is a command for each individual to be part of the unified group.

Trustee MacFarlane then gave the acknowledgement:

We would like to acknowledge the nations on whose traditional territory we are gathering: the Sinixt, the Ktunaxa, the Secwepemc, and the Syilx.

ADMINISTRATION REPORTS

SUPERINTENDENT HOOKER

Administration Report: Superintendent Hooker

Received as information.

Superintendent Hooker presented his Administration Reporting highlighting the ongoing weekly virtual updates from Ministry of Education the most recent one included Dr. Reka Gustfson, the Deputy Provincial Health Officer who reiterated that the current increase in COVID19 cases in the province is due to social gatherings and household contacts, not school contacts. He also noted the ongoing construction at Columbia Park Elementary School and that he and Secretary Treasurer Tisdale recently met with staff to discuss their concerns. The possibility of rotating an early dismissal time to reduce the number of students in the building at the same time was discussed, taking into account that alternate activities will need to be offered for those families that require childcare. He brought trustees attention to the upcoming Middle Years Development survey, the additional staffing levels at Columbia Park Elementary School, the work on the 2021/2022 school calendar, and the anonymous donation to the Revelstoke Secondary School music program.

Policy No. 5.6 Sexual Orientation and Gender Identity

Trustee Zimmer presented the policy noting that a great deal of work went into updating the language to reflect more current definitions and how those words are used. The definition of Two Spirit was forwarded to the Indigenous Education Committee for their input which was greatly appreciated. This policy is a living document and will need to be regularly updated.

Childhood Experiences Questionnaire (CHEQ) from the Human Early Learning Partnership

Superintendent Hooker reviewed the charts noting that the memo is only a small sampling of the questionnaire. Despite the pandemic, 68 of 77 families completed the questionnaire. The results are consistent with the results we see in in the Early Development Instrument (EDI). The CHEQ and the EDI are designed to complement each other with the CHEQ being completed by families as children enter Kindergarten and the EDI is completed by Kindergarten teachers part way through the year.

SECRETARY TREASURER TISDALE

Long Range Facility Plan

Secretary Treasurer Tisdale presented the final version of the Plan which incorporates the changes discussed at the November 10th, 2020 Finance and Facilities meeting. Trustees noted that the City of Revelstoke should be provided with a copy of the Plan.
