SUPERINTENDENT HOOKER

Administration Report: Superintendent Hooker

Received as information.

Superintendent Hooker presented his Administration Report highlighting the ongoing meetings taking place between the school district and the Ministries of Health and Education. The Ministries are keeping districts up to date on any changes to health and safety guidelines for schools and providing advance notice prior to changes taking place. Superintendent Hooker advised that he has been out in schools, as has RTA President Barry Rourke, to meet with staff

to ensure they are comfortable with the January 10th, 2022 restart as there is understandably higher levels of stress and anxiety due to the high rate of infection in Revelstoke. The safety plans currently in place are working and students continue to participate in regular activities such as lunch time sports, downhill skiing, cross country skiing, snowshoeing, etc. There has been a slight increase in student absences since January 10th, but staff attendance remains consistent.

Trustees expressed their appreciation to staff recognizing the challenges they continue to face on a daily basis. Although there is fatigue with the virus, the district will continue to follow provincial health and safety guidelines.

Policy 2.1 Procedural Bylaw

Paragraph 2.4.1 of the Bylaw was amended to change the words "Call to Order and Acknowledgement of Traditional Aboriginal Territories to "Call to Order and Recognition of Territory". Trustee Zimmer suggested changes to the policy to amend the gender specific language to inclusive language. The changes will be incorporated into the bylaw.

Vaccination Policy Update

Superintendent Hooker presented the memorandum explaining that the motion set out in the memo was passed by the Revelstoke Board of Education at an "In Camera" meeting on Tuesday, January 11th, 2022. The memo provides background information on the vaccine policy implementation process as well as a copy of the motion passed. He confirmed that he has had conversations with the Deputy Minister of Education and Dr. Karin Goodison, Medical Health Officer regarding the Board's decision to implement a vaccination policy, both are supportive of the process the district is following. Dr. Goodison noted the high vaccination rates in Revelstoke and advised that Interior Health will support the district in any way possible in its implementation of the policy.

Trustees noted that Superintendent Hooker and Secretary Treasurer Tisdale have followed the K-12 Sector Guidelines for Vaccination Policies provided by BC Public School Employers Association and Ministry of Education and that the Board has been discussing a vaccination policy since October 2021 when the Guidelines were provided to district. Trustees expressed their thanks to district staff and to the BC Teachers' Federation and CUPE for their support of vaccination policies in school districts to support the health and safety of students.

SECRETARY TREASURER TISDALE

Secretary Treasurer Tisdale presented his memorandum noting that over the next 6 weeks the 2021/2022 budget will be amended and presented to Trustees at a Finance and Facilities meeting for approval before submitted the amended Budget to the Ministry of Education. He does not anticipate many changes to the Budget.
