#### SUPERINTENDENT HOOKER

Administration Report: Superintendent Hooker

Received as information.

Superintendent Hooker presented his Administration Report highlighting the upcoming meeting with the UBC Human Early Learning Partnership Research Team to discuss their project here in Revelstoke. He also noted the District Leadership's work on school learning plans, and the "Food Truck" student project at Columbia Park Elementary School. Both he and Board Chair

MacFarlane were able to visit the school and see the food trucks students created using art, coding, created advertising for, grocery shopping for the items and costing the food truck items they would sell. Superintendent Hooker noted the discussions taking place with respect to the BC Human Rights Tribunal's Special Programs related to preferential hiring of Indigenous staff and the K-4 Explorations Inquiry project taking place at Columbia Park Elementary School which involves cross grade groupings of students "exploring" areas of interest to them. The goal of the project is to enhance the connections with staff and students which have been impacted by COVID. He added that the Kindergarten registration numbers for the 2022/2023 school year have now increased to 80 in total. He reviewed the items discussed in the Superintendents' meeting with the Ministry of Education.

Finally, he confirmed that the K-12 Health and Safety Guidelines provided to school districts at the end of December during the high infection rates of COVID have been withdrawn and districts are returning to the health and safety guidelines set out in the Fall of 2021. This change will be gradually implemented beginning with school assemblies which will now allow for primary grades to be together for assemblies and intermediate grades to be together for assemblies and the attendance of parents at after school events such as the elementary basketball wind-up taking place at Revelstoke Secondary School. The province has provided rapid tests directly to schools and those will be sent home to families unless families have indicated that they do not want them.

#### Board Authority Authorized Course – Recreational Leadership 10-12

Superintendent Hooker presented the course noting that after further review, Revelstoke Secondary School has asked that grade 10 be included in the course. The course will be Recreational Leadership 10-12 rather than of 11-12.
