SUPERINTENDENT KUBIK

Administration Report: Superintendent Kubik

Received as information.

Superintendent Kubik presented her Administration Report highlighting the Cooperative Cohort ZOOM sessions she has attended with Rita Tedesco, District Principal of Student Learning and Inclusion and Jodi Wallach, District Principal of Indigenous Education and K-12 Well-Being,

adding that the district has assigned the two Elementary Indigenous Student Assistants to specific schools rather than have them work in all four elementary schools. This will allow them to develop deeper relationships with the students. During the last session, the district put forward things that we are proud of as well as the challenges. The district's main challenge is that there are no specific bands in Revelstoke. Much of the knowledge comes from the Revelstoke Indigenous Friendship Society and bands outside of the district. The hope is that once the weather improves, students will be able to visit the bands in other communities. Another item Superintendent Kubik highlighted was the Cultural Performance by Karmia Essa (Body Positive Bollywood dance). Ms. Kubik attended the performance at Begbie View Elementary School which was thoroughly enjoyed by staff and students. Students participated in the dance and particularly enjoyed it when staff performed a short dance routine. This event was coordinated in partnership with the Revelstoke Performing Arts Centre.

The Framework for Enhanced Student Learning Cooperative Component Update/Ministry of Education and Child Care

Superintendent Kubik explained that the district is part of a cooperative component. Any school district with two years left under its strategic plan is part of the process. Our district is in a cohort with 9 other districts. Our district has so far completed all of the data dives. Later in the process a peer review will take place to discuss what has been done and where the district is going. Every district will go through this process on a four year cycle.

SECRETARY TREASURER TISDALE

2022/2023 Amended Annual Budget

Secretary Treasurer Tisdale presented the 2022/2023 Amended Annual Budget noting that it reflects the direction the Board set in the original Budget in June of 2022. The Amended Budget was reviewed by the Finance and Facilities Committee at its February 6th, 2023 meeting. The district's priority continues to be maintaining class sizes that are under the provincial targets and maximizing course options at Revelstoke Secondary School. Secretary Treasurer Tisdale added that the district has received funding from the Ministry of Education and Child Care for the negotiated salary increases to staff.

Trustees thanked Secretary Treasurer Tisdale for his work on the amended budget.

Affordability Fund Update

Secretary Treasurer Tisdale explained that the Affordability Fund is funding announced by the Ministry of Education and Child Care in the Fall of 2022 for the 2022/2023 school year. The funding is to be used to provide temporary support to families facing financial challenges. He confirmed that the district has met with various partner groups and school principals to determine which families require support and decide specific ways to support each of those families. Some of the things the funds have been used for are:

- Backpack program which provides elementary school students with backpacks full of food on a Friday which they take home. The empty backpack is brought back to school the following week to be refilled.
- Purchase of winter clothes (boots, jackets)
- Enhancement of the existing breakfast program
- Special funding for school activities like book fairs and lunch days
- Restocking of school food cupboards

The district is always open to new ideas. Some of the items the district is considering include offering an after-school activity for students who would be going home to an empty house, grade 7 end of year trip, and grad activities to name a few.

As the Affordability Fund was only for the 2022/2023 school year, the district will be holding back some funds in order to continue the key programs in the 2023/2024 school year should the Affordability Fund not be provided to districts for the next school year.
