CALL TO ORDER

Trustee Chell called the meeting to order at 4:58 p.m.

DELEGATIONS

Melissa Hemphill, Food Security Coordinator, Community Connections

Melissa Hemphill began her slide presentation by providing the history and some background information on the City's Food Security Strategy. The definition of "Food Security" is that all community residents have access to nutritious, safe, affordable food that meets our needs, supports our culture and is produced in ways that are environmentally sound, socially just,

adaptable to change and supportive of self-reliance and collaboration. The goals of the Food Security Strategy are:

- Access to Food
- Environmentally sustainable food production
- Economic stability
- Food culture
- Education

There are many challenges to provide food security. Interior Health lists 14% of households in the region are food insecure. It is estimated that only 1.76% of Revelstoke's food needs can be satisfied locally. Ms. Hemphill reviewed some of the successes including increased public understanding and the growth of local food businesses in Revelstoke and the many "players" involved including the school district. A slide with the list of the current SD19 projects was shown.

There are gaps in the strategy such as

- food production access to land to grow produce
- indigenous food sovereignty
- connection to region working to improve collaboration with neighbouring communities and food bank networking.

Ms. Hemphill provided a slide with a list of recommendations for the school district as well as a spreadsheet.

Trustees thanked Ms. Hemphill noting that they will review the recommendations provided by her.

Ms. Hemphill left the meeting.

Sarah Newton, Teacher – Presentation on the results of her Teacher Wellness Survey Results

Sarah Newton began her presentation by explaining that the survey she conducted was her Teacher Inquiry Project the purpose of which was to have a better understanding of the level of wellness amongst teachers. She introduced Colleen Wall, Teacher and her Inquiry Project mentor. Ms. Newton then reviewed the survey results as follows:

- 47 teachers participated in the survey, 14 from Revelstoke Secondary School and 33 from the three elementary schools
- 77% felt that they are experiencing "burnout" and the top five causes listed were:
 - Teachers feel they do not have enough time to do student assessments
 - Classroom management and behavioural challenges
 - > Finding time for meetings
 - Not enough support to meet the needs of students on an Individual Education Program (IEP)
 - Preparing for lessons

Some of the suggestions to reduce "burnout" are:

- More prep time
- More classroom support for students with IEPs
- More release time for collaboration
- More in-service time to learn how to implement Ministry and District mandated programs.

Ms. Newton acknowledged that these issues are not unique to Revelstoke and that BC Teachers' Federation conducted a province wide membership survey this year.

Trustees thanked Ms. Newton for her presentation acknowledging the important work teachers do. The Board will review the survey results to consider what actions can be taken to improve the well-being of staff.

Sarah Newton and Colleen Wall left the meeting at 5:32 pm.

SPECIAL REPORTS

<u>Arrow Heights Elementary School Annual Report</u> to the Board presented by Pam Mair, Principal

Principal Mair began by noting that she has been the Principal of Arrow Heights Elementary School since November 1st, 2023 and is loving every minute of it. *At AHE we place students at the center and lead with our beliefs that learning is holistic, reflexive and experiential. Central to our school culture are the First People's Principles of Learning. Through quality learning opportunities, our intention is to instill a focus on connectedness to the environment and each other on reciprocal relationships with the land and people, while developing a sense of gratitude for our place. Principal Mair highlighted the focus on Indigenous Education noting that during assemblies, students make the land acknowledgement their own by stating something they are grateful for where they live. Some of the other things the school does to incorporate the First Peoples Principles of Learning are:*

- Indigenous language on the announcements
- Outdoor classrooms
- Circles of Learning
- Elder visits

Arrow Heights Elementary School fosters a safe and welcoming learning environment and the CARES (Cooperate, Achievement, Respect, Enthusiasm, Safety) program supports students in building empathy and caring for the community.

Principal Mair reviewed the school's classes and staff noting that for the 2023/2024 school year the school will have over 200 students. Most teachers at AHE are part-time. The teachers support each other and collaborate through fun social events, such as "soup day" every Tuesday and out of school activities such as snowshoeing together on the flats. The school has 3 assemblies a month. 1 is a whole school assembly, 1 is a primary assembly that Principal Mair and the school's Educational Assistants supervise so the primary teachers can do planning or work on report cards and the other assembly is for intermediate teachers to do their planning or report cards.

The Student Learning and School Learning Plan in the areas of Literacy, Numeracy and Social Emotional Learning was reviewed together with the data that was gathered through the various assessment tools. In summary the data gathered through PM Benchmarks, the Foundation Skills Assessment and the Middle Years Development Instrument indicates that AHE is doing very well.

At the end of her presentation, Principal Mair shared a slide show of students and staff engaged in the various activities that took place during the year.

Trustees and Superintendent Kubik thanked Principal Mair for her presentation and asked her to pass on the Board's thanks and appreciation to her staff.

Superintendent Kubik presented her Administration Report highlighting her participation in the PreVenture Zoom meeting presented by the Healthy Schools Team and Interior Health and her meeting with Revelstoke Secondary School Counsellor Lissa Cancilla-Sykes to learn about the various counselling programs and medical services offered at the school. She also noted the successful elementary school band concert held at the Revelstoke Performing Arts Centre.

<u>Human Early Learning Partnership – Revelstoke Community Profile</u>

Superintendent Kubik noted that a recent meeting was held in Kamloops which Rita Tedesco, District Principal of Student Learning and Inclusion attended. At the meeting, the success of Revelstoke (one of the first districts to participate in the Early Childhood Development Instrument) was highlighted. She noted that the surveys conducted through the Human Early Learning Partnership assist staff in determining the direction for schools.
