Regular Board Meeting September 19th, 2023 Minutes

CALL TO ORDER

Trustee Chell called the meeting to order at 5:02 p.m.

We would like to respectfully honour the four nations on whose land we live and learn: the Sinixt, the Ktunaxa, the Secwepemc, and the Syilx.

Board Chair Chell gave a brief overview of the history of the St. Eugene Resort in Cranbrook. The St. Eugene Mission which was a residential school from 1912 until 1970, sat empty for over 20 years before four Ktunaxa bands held a referendum and voted to resort the building. It took 10 years for the restoration process to turn the former residential school into the St. Eugene Resort which now boasts a 18 hole golf course, a casino and an RV Park.

2022/2023 Audited Financial Statements

Administration Report: Superintendent Kubik

Superintendent Kubik presented her Administration Report highlighting:

- her attendance at the BC School Superintendents' Association Summer Leadership conference
- the trustee planning day
- the August 30th, 2023 district-wide school planning day
- the August 31st, 2023 professional development day

She noted her visits to schools on the Labour Day weekend. During her visits she encountered many staff members in the schools preparing for the start of the school year. She also noted her meetings with the student leadership committee at Revelstoke Secondary School.

Early Learning and Child Care Environmental Scan

Board Chair Chell advised that the Ministry of Education and Child Care set aside funds for districts to complete early learning and child care environmental scans. Superintendent Kubik presented a summary of the Environmental Scan done in Revelstoke. She noted that retired Superintendent Mike Hooker was contracted to do the Environmental Scan. Mr. Hooker interviewed 17 groups for the scan. In summary, Revelstoke is known for great work in the area of early learning. However, the impact of the pandemic is still being felt. There is a need for more child care spaces. The scan will be sent to participants and partner groups with a thank you letter thanking them for their participation.

Draft Committee and Representative Appointments

Trustees were provided with the draft list and asked to review and provide any preferences/changes to Superintendent Kubik by October 2nd, 2023 for approval at the October 18th, 2023 board meeting.

With respect to the "food funding" that the district requested in late Spring, the amount of \$82,000 was approved by the Ministry of Education and Child Care. These funds are being used to install commercial deep freezers and commercial dishwasher in each school.
