## **SUPERINTENDENT KUBIK**

Administration Report: Superintendent Kubik

Received as information.

Superintendent Kubik presented her Administration Report highlighting her Friday visits to a grade 6/7 class at Begbie View Elementary School to do "Brain wake-up" movements, and Susan Leslie's visit to the district to do professional development with K/2 teachers on "Pedagogy of Student Voice" using circle protocol and numeracy labs based on the book *Street Data*. Superintendent Kubik also highlighted the district-wide student services meeting she attended, her meeting with Lissa Cancilla-Sykes, RSS Counsellor and her meeting with Rita Tedesco, District Principal of Student Learning and Inclusion, Monica Penner, District Speech Language Pathologist, and Andrew Sykes, District Psychologist, to review the student referral process.

# Revision to Indigenous Acknowledgement

Trustee Zimmer reviewed the revisions explaining the addition of "Okanagan" to Syilx and the change in the order the nations based on the amount of time the nation spent in the area. This is an example of growing through reconciliation, as new information is learned we make changes and continue to move forward.

# 2023/2024 Organization of Classes and Non-Enrolling Report

Superintendent Kubik presented the annual report. She noted that the non-enrolling ratios fluctuate based on the size of the cohort. Historically, Revelstoke's non-enrolling ratios are consistently lower than the provincial ratios. She then reviewed the class size averages, the enrolment at each school and the class size ranges at Revelstoke Secondary School. She thanked the Board for continuing to support smaller class sizes through the budget process.
